Founded in 2001, BACtrack is one of the pioneers of the breathalyzer industry. In 2004, it was the first company to obtain FDA approval to manufacture and market breathalyzers for consumer use in the United States. Since then, BACtrack has grown into a global leader in the alcohol testing and monitoring space, providing some of the most accurate and innovative breath alcohol testing devices and software on the market.

Launched in 2016, BACtrack View was designed to fit the specific needs of treatment centers, health clinics, businesses and individuals, making it easy and affordable to remotely monitor the sobriety of users, directly from a smartphone. It currently supports thousands of users, testing multiple times per day, typically several days per week. To date, over one million video breath alcohol tests have been recorded, processed and securely stored on the BACtrack View platform.



ABOUT THE SERVICE

<u>BACtrack View</u> is an app-based remote alcohol monitoring service, designed to track the sobriety of users by providing a video of their breath alcohol tests to the person or organization monitoring them.

Testers are given a BACtrack Mobile Smartphone Breathalyzer to use while on the service, which connects to the BACtrack View App on an iPhone or iPad via Bluetooth. When it's time to take a test, the Tester receives a notification on their phone, which prompts them to turn on their breathalyzer and record themselves taking the test. The BAC results and video, along with the date, time and GPS location are uploaded to the BACtrack View App in near real-time for review by their Manager

Each Tester is assigned a Manager, who can request on-demand tests, set recurring or randomized testing schedules, view previous test video results, and download a summary PDF report of that user's test history. Managers have the option to receive Email or SMS notifications when an MU fails or misses a test. Additional Managers within the organization also have the option to receive these notifications.

Set Testing Schedule

Request a BAC Test

Automated notifications tell a user when it's time to test. BACtrack Mobile and the BACtrack View app offer easy and discreet BAC testing.

Get Real-Time Results

Video and location-verified BAC results are captured and saved via the App, and automatically shared with Monitors via Text or Email.
