Attorney's Note

Sample 2-2-3 Parenting Schedule Clause

Residential Schedule

The parties agree to the following regular residential schedule, resulting in each parent having approximately 50% of the custodial time with the child(ren) over a two-week cycle:

- **Week One**

- **Parent A** shall have the child(ren) from Monday at 9:00 a.m. through Wednesday at 9:00 a.m.
- **Parent B** shall have the child(ren) from Wednesday at 9:00 a.m. through Friday at 9:00 a.m.
- **Parent A** shall then resume time with the child(ren) from Friday at 9:00 a.m. through Monday at 9:00 a.m.

- **Week Two**

- **Parent B** shall have the child(ren) from Monday at 9:00 a.m. through Wednesday at 9:00 a.m.
- **Parent A** shall have the child(ren) from Wednesday at 9:00 a.m. through Friday at 9:00 a.m.
- **Parent B** shall then resume time with the child(ren) from Friday at 9:00 a.m. through Monday at 9:00 a.m.

This schedule shall alternate weekly and repeat continuously unless modified by the Holiday Schedule or additional court orders.

Parenting time table (2-2-3 schedule)

Day	Parenting Time	Parent
Monday	Parent A	Parent B
Tuesday	Parent A	Parent B
Wednesday	Switch at 9:00 a.m. – Parent B	Switch at 9:00 a.m. – Parent A
Thursday	Parent B	Parent A
Friday	Switch at 9:00 a.m. – Parent A	Switch at 9:00 a.m. – Parent B
Saturday	Parent A	Parent B
Sunday	Parent A	Parent B

Holiday and Vacation Schedule

The parties shall follow a separately agreed-upon Holiday and Vacation Schedule, which will take precedence over the regular schedule. Unless otherwise agreed, major holidays shall alternate annually.

Transportation Responsibilities

Unless otherwise arranged, the parent beginning their parenting time shall be responsible for transportation at the time of exchange.

Communication and Flexibility

Both parents agree to communicate respectfully and to cooperate in accommodating school events, activities, family traditions, and special circumstances. Minor deviations from the schedule may be made by mutual written agreement without court involvement.

Alcohol Monitoring (if applicable)

If a parent is subject to alcohol monitoring, they shall use BACtrack View or an approved equivalent. The monitored parent shall submit breathalyzer tests at the beginning, midpoint, and end of each parenting time period. Results will be shared in real time with the other parent, and any missed or failed test shall trigger the agreed-upon contingency terms in this Parenting Plan.

Duration of Schedule

This parenting schedule shall remain in effect unless and until modified by written agreement of both parties or further order of the Court.
